Here is How to Start

Is your organization a national or local nonprofit organization with 501(c)3 status; a state, county, or local government entity; an Indian Tribe or Tribal organization; an institution of higher education; a K-12 educational institution; a faith-based organization; an association or consortia of educational and/or community organizations?

CONCEPT PAPER

Submitting a Concept Paper is a mandatory first step in the EngageAR/Arkansas Service Commission application process. After successful submission and review of the concept paper, organizations will be invited to submit an application for AmeriCorps funding. The Concept Paper phase of the application process is designed as a “qualifying” round. Applicants with a clear method of addressing a need and the potential to develop a strong AmeriCorps program will be formally invited to apply. Final AmeriCorps applications, with detailed narrative and budget will be due Monday, February 1, 2021.

Fall 2021	2021 – 2022 Program year begins



PLANNING GRANTS

Planning grants allow time and financial resources for organizations to determine and explore the feasibility of applying for an operational AmeriCorps grant. Approval of a planning grant does not guarantee an organization will be approved for an operational grant. Planning grants do not support AmeriCorps members.

OPERATIONAL GRANTS

Organizations awarded funding for an operational grant will engage AmeriCorps members to expand and/or enhance an organization's activities. ASC's general practice is to award no fewer than four (4) MSY with no more than 50 member slots for new grantees.

November 4, 2019	New Formula Application Concept Paper Package Due including: Concept Paper, Organizational Readiness Assessment, Draft Member Position Description Due
February 20, 2020	Formula applications due along with other submission requirements (see page 14 in application package)
April 3, 2020	Feedback and opportunity to resubmit applications provided
April 17, 2020	Updated formula applications dues
May 1, 2020	Governor's Advisory Commission on National Service and Volunteerism votes on formula applications
June 26 - July 3 (TBD)	Notification of formula awards
