County Situation Report from Office of Emergency Services and EOC: Lynn Pesely

- 1,090 cumulative positive tested in Sac County, 42 deaths
- Sac Public Health Officer ordered effective May 1 22nd reinforces direction to-stayhome & extends social distancing
- COVID-19 FREE testing w/ appt at CalExpo 18 yrs+. Must have car (no UBER, no LYFT) https://www.projectbaseline.com/study/covid-19/

KEY CHANGES

- Preventative health care now implemented (immunizations, dental care, elective surgeries)
- Non-contact recreation facilities including shooting, archery, disc golf, boating, etc. as long as people maintain physical distancing while disinfecting equipment
- Residential viewings for home-sales & home Leases
- Food trucks now in operation implementing social distancing
- Places of Worship, indoor concerts, etc will not open May 22. Large indoor groups will be laterlast phase

Additional weekly direct food distribution

- Continuing large distribution sites: Encina High School & Christian Brothers High School with increased produce and dry goods services
- 22 pallets sent to Paratransit to distribute senior food boxes to residents
- Partner agencies/food pantries meeting needs serving 225,000 people with a fraction of operating agencies in operation (normally 150,000 people served by 230 agencies in non COVID-19 times)

- Teamed with Sheriff team at Sacramento Food Bank. 195 emergency boxed meals.
- Serving at CA Emergency FoodLink helping distribute 54,000 meals to statewide providers
